LETTER OF INSTRUCTION – 2025

ANNUAL RETURN OF MEMBERS. A Return becomes due each year and will be **emailed** to you, in the first instance. It should be checked, updated and returned, **in its entirety** duly signed and **accompanied by a remittance for the appropriate Annual Dues.** We recommend that the following email addresses are added to your safe senders list: acroc@ugle.org.uk and registration@ugle.org.uk **The full amount is payable for every Brother whose name appears on the Return, whether they are clear on the Lodge books or not and includes those whose membership commenced or ceased during the year covered by the Return.**

REGISTRATION FORM P. This form requires all the relevant information to be completed to enable the successful registration of a member. Once completed it should be forwarded **immediately after their admission** with the appropriate and current fee. This form is now available as a pdf and can be obtained by emailing your Provincial office or registration@ugle.org.uk **N.B. The Craft Registration Fee now includes the Fee to be exalted into the Royal Arch.**

LP&A4 (INSTALLATION RETURN - MASTER, WARDENS & PAST MASTERS). The LP&A4 form must be completed and returned **immediately after the Installation Meeting.** This form is available electronically and will be emailed to you shortly before the Installation Meeting.

LP&A5 (APPLICATION FORM FOR ISSUE OF A GRAND LODGE CERTIFICATE). Application should be made on Form LP&A5 immediately after a Brother has been raised **and received the Traditional History.** This form is available electronically and can be obtained by emailing your Provincial office or registration@ugle.org.uk

The reference to be used **must** be your Lodge number and what the payment is for, e.g. LXXXX (*your Lodge number*) then AR 2025 (*for Annual Dues*), LXXXX RF (*for Registration Fees*), LXXXX Disp (*for Dispensations*) and LXXXX RC (*for Replacement Grand Lodge Certificates*). It is **imperative** that when sending in a hard copy of the relevant form or letter (if applying for a Replacement Grand Lodge Certificate), you clearly state that payment has been made by bank transfer and provide relevant details i.e. the amount paid, date and reference used.
